

Terms and Conditions:

1. This “Galaxy Macau x HSBC Spending Rewards Campaign” (“Promotion”) is organized by New Galaxy Entertainment 2006 Company Limited (“NGE2006CL”).
2. The Promotion runs from 1 April 2026 to 30 June 2026 between 10:00 A.M. to 11:59 P.M. (“Term”).
3. To participate in the Promotion, participants must first register as Galaxy Macau WeChat Member if you are not currently an existing member.
4. Participants must be at least 21 years of age to participate in the Promotion.
5. To qualify, participant who makes Eligible Transactions* at the restaurants of Galaxy Macau or the designated retailers of Galaxy Promenade using Eligible Credit Card# upon reaching the designated cumulative same day spending amount during the Term can receive rewards valued up to MOP1,800. Details as below:

***Receipts for any purchase of (a) pure gold only products; or (b) gift cards (including but not limited to coupons or vouchers) from or issued by participating retail shops; or (c) products from Apple Store; or (d) products from Luzhou Laojiao · Guojiao 1573 Pop-up; are ineligible for the Promotion.**
- b) Same-day sales slip(s);
- c) The Eligible Credit card used for transaction(s);
- d) Valid original identification document; and
- e) Galaxy Macau WeChat membership card.

Where a participant's name appears on the relevant receipt(s), such name shall match the name appearing on the identification document, Galaxy Macau WeChat membership card presented by the participant, or, unless otherwise, NGE2006CL is satisfied that the redemption is made by an eligible participant in person in accordance with these terms and conditions.

- 7. Participants must present one (1) single receipt or no more than two (2) receipts issued by the designated restaurants or retailers in order to be eligible for the rewards. If two (2) receipts are present, they must be issued by two (2) different restaurants or retailers.
- 8. Galaxy Macau F&B Gift Certificate and Galaxy Promenade Shopping Privilege Voucher are awarded in the form of electronic vouchers. The usage of the vouchers is subject to separate terms and conditions. Galaxy Macau F&B Gift Certificate can be used as cash at the designated restaurants at Galaxy Macau. Galaxy Promenade Shopping Privilege Voucher can only be used at designated retailers of Galaxy Promenade upon making a single purchase that meets the minimum spending amount of MOP700.
- 9. Rewards are available on a first-come-first-served basis, while stocks last.
- 10. Each official receipt/sales slip can only be used once for redemption and cannot be used in conjunction with other promotional offers.
- 11. Each cardholder is entitled to redeem up to a maximum of three (3) times within the Term of the Promotion.
- 12. Copied, defective, defaced, damaged or tampered receipt(s) or receipt(s) not issued on the same day of redemption will not be accepted by NGE2006CL.
- 13. All Galaxy Macau Dining Voucher(s) and Galaxy Promenade Shopping Privilege Voucher(s) must be used within thirty (30) days after the redemption.

- 14.** Deposit receipts, hand-written or reprinted invoices or receipts for the purchase of gift cards (including but not limited to coupons or vouchers) from any retail shops will not be accepted by NGE2006CL for redemption purposes.
- 15.** Redemption must be made by eligible shoppers in person. Owners and employees of any retail shops at Galaxy Promenade and any employees of the Galaxy Group (as defined below) are NOT allowed to redeem on behalf of any shopper.
- 16.** Redemption registration with any incomplete or false information may be rejected by NGE2006CL acting in its sole and absolute discretion.
- 17.** Owners and employees of any retail shop of Galaxy Promenade are NOT eligible to participate in this Promotion.
- 18.** Employees of Galaxy Group are eligible to participate in this Promotion.
- 19.** All Galaxy Macau F&B Gift Certificate(s) or Galaxy Promenade Shopping Privilege Voucher(s) are non-transferable, non-refundable, have no cash value, and cannot be exchanged for any other item.
- 20.** The Galaxy Promenade Shopping Privilege Voucher(s) can only be used in designated retailers at Galaxy Promenade listed in <https://www.galaxymacau.com/en/shopping-gift-voucher>.
- 21.** Galaxy Macau F&B Gift Certificate(s) or Galaxy Promenade Shopping Privilege Voucher(s) may not be resold or transferred to a third party. In case any Galaxy Macau F&B Gift Certificate(s) or Galaxy Promenade Shopping Privilege Voucher(s) is found to have been resold or transferred, the seller/transferor will be charged at the full retail value and best available rate (as applicable), and both the seller/transferor and buyer/transferee will be disqualified from participating in all future promotions and lucky draws organized by any member of the Galaxy Group.
- 22.** All merchandise referred to by any receipt(s) presented for redemption of the rewards shall be non-refundable. All receipt(s) presented for redemption shall be stamped as proof of successful redemption.
- 23.** All merchandise purchased with Galaxy Promenade Shopping Privilege Voucher(s) shall be non-refundable at any retail shops.

- 26.** By participating in the Promotion, shoppers hereby authorize NGE2006CL and its affiliated companies (collectively, the "Galaxy Group") to collect, use, store, analyze and process by any means and whether in Macau or in another jurisdiction the shoppers' personal information ("Data"), for the purposes stated herein as well as for marketing any casino, food and beverage, accommodation, entertainment related services and products, including via direct marketing. Spenders consent to the confidential communication and transfer of the Data to such service providers (properly licensed to provide such services under Macau law) who are engaged by the Galaxy Group at any time to assist with the administration, analysis and management of the Data. For the purpose of providing services to you, we may seek your separate consent to our disclosure to our employees, agents, contractors, subsidiaries, affiliates and third party providers, our collection and use of sensitive Data, or cross-border Data transfer activities involving other jurisdictions. Shoppers have the right at any time to

update or revise their Data, or refuse or withdraw their consent for Data treatment provided herein by choosing to unsubscribe to any electronic newsletters or marketing communications, or by calling the customer services hotline at +853 8886 1027.
