

Multiple Redemption Offer – Terms and Conditions

1. Promotion period: 1st April 2026 – 30th June 2026.
2. This offer is only eligible for accumulated spending of MOP48,000 at the designated outlets in StarWorld Hotel / Galaxy Macau / Broadway Macau during the quarterly designated period.
3. The last spending date of the second quarter of 2026 is 30th June 2026.
