



**Terms and Conditions:**  
**條款及細則：**

1. This “Galaxy Arena Event Shopping Privileges” redemption (“Redemption”) is organized by New Galaxy Entertainment 2006 Company Limited (“NGE2006CL”).

本「銀河綜藝館活動購物禮贈」活動（以下簡稱「換領活動」）由新銀河娛樂2006有限公司（以下簡稱「本公司」）舉辦。

2. The Redemption runs from 10:00 A.M. on 22 May until 10:00 P.M. on 31 May 2026 (“Term”).

換領活動由2026年5月22日早上10時開始至2026年5月31日晚上10時00分截止（以下簡稱「活動期間」）。

3. Shoppers who participate in this Redemption to enjoy the rewards must have registered as either GEG Privilege Club, JINMEN Premium Club or GALAXY ULTIMATE members or be employees of Galaxy Group (as defined below).

活動期間，凡參加換領活動之顧客必須已登記成為銀娛優越會、金門尊尚會、「銀河致尚」會員或銀河娛樂集團員工。

4. Shoppers must be at least 21 years of age to participate in the Redemption.

5. During the Term, any eligible shopper who spends an aggregate amount referred to in sub-paragraphs 5.1.1 below in either one single transaction or accumulated in maximum two transactions and evidenced by official receipts\* issued by select retail shops (only one transaction per shop is permitted) located at Galaxy Promenade, Galaxy Macau is entitled to redeem the rewards below on the same day of the purchase transaction(s):

7. During the Term, all registrations and redemptions shall be made in person at the below Registration & Redemption Counters at Galaxy Promenade, Galaxy Macau from Sunday to Thursday between 10:00 A.M. to 10:00 P.M.; Friday, Saturday, Public Holidays (& night before) between 10:00 A.M. to 12:00 A.M.:

8. To join the Redemption, an eligible shopper shall present the following items at the Registration & Redemption Counters:

\*Receipts for any purchase of (a) pure gold only products; or (b) gift cards (including but not limited to coupons or vouchers) from or issued by participating retail shops; or (c) products from Apple Store; or (d) products from Moutai Pop-Up; or (e) at restaurants, cafes, and Tastes of Asia are ineligible for the Redemption.

- 8.1.4. Galaxy Arena “UFC Fight Night Macau” or “Road to UFC” ticket (held during the Term).

\*Screen captured, copied, defective, defaced or damaged or tickets(s) will not be accepted for redemption purpose.  
本公司恕不接受截圖、副本、不完整、毀壞、損毀或竄改的門票。

9. Where a shopper's name appears on the relevant ticket (s) such name shall match the name appearing on the identification document, GEG Privilege Club card, JINMEN Premium Club card, GALAXY ULTIMATE electronic card, Galaxy Group (as defined below) staff card presented by the shopper, or NGE2006CL is otherwise satisfied that the redemption is made by an eligible shopper in person in accordance with these terms and conditions.

10. All Galaxy Promenade Shopping Privilege Voucher(s) referred to in sub-paragraphs 5 above must be used within seven (7) days after the redemption.

11. No more than 4 Shopping Privilege Vouchers may be used by any shopper in a single purchase at any of the participating retail shops, provided that the aggregate minimum spending amount indicated on the Shopping Privilege Vouchers is met.

12. All Galaxy Promenade Shopping Privilege Voucher(s) require minimum spending and are subject to the terms and conditions set forth therein.

13. Each official ticket can only be used once for this Redemption and cannot be used in conjunction with other promotional offer.

14. Copied, defective, defaced, damaged or tampered ticket (s) not issued for the Redemption will not be accepted by NGE2006CL for Redemption purposes.

15. Deposit receipts, credit card sale slips, hand-written or reprinted invoices or gift cards (including but not limited to coupons or vouchers) from any retail shops will not be accepted by NGE2006CL for Redemption purposes.

16. Redemption must be made by eligible shoppers in person. Owners and employees of any retail shops at Galaxy Promenade and any employees of the Galaxy Group (as defined below) are NOT allowed to redeem for any shopper.

18. Owners and employees of any retail shop of Galaxy Promenade are NOT eligible to participate in this Redemption.

19. Employees of Galaxy Group are eligible to participate in this Redemption.

銀河娛樂集團員工可參加本換領活動。

20. Copies, defective, defaced, damaged or tampered Galaxy Promenade Shopping Privilege Voucher(s) will not be accepted.

本公司恕不接受任何影印、不完整、毀壞、損毀或竄改的銀河時尚匯購物優惠券。

21. Lost, stolen or damaged Galaxy Promenade Shopping Privilege Voucher(s) will not be reclaimed, refunded or replaced by NGE2006CL.

銀河時尚匯購物優惠券如有遺失、被盜或損毀，恕不獲本公司回收、退款或更換。

22. To use the Galaxy Promenade Shopping Privilege Voucher(s), shoppers must present the original Galaxy Promenade Shopping Privilege Voucher(s) together with the original identification document of the shopper.

23. All Galaxy Promenade Shopping Privilege Voucher(s) are non-transferable, non-refundable, have no cash value, and cannot be exchanged for any other item.

25. The Galaxy Promenade Shopping Privilege Voucher(s) may not be resold or transferred to a third party. In case any Galaxy Promenade Shopping Privilege Voucher(s) is found to have been resold or transferred, the seller/transferor will be charged at the full retail value and best available rate (as applicable), and both the seller/transferor and buyer/transferee will be disqualified from participating in all future promotions and lucky draws organized by any member of the Galaxy Group.

26. All merchandise referred to by any receipt(s) used to enter the Redemption shall be non-refundable. All receipt(s) used to redeem Galaxy Promenade Shopping Privilege Voucher(s) shall be stamped as proof of successful redemption.

28. The Redemption may be cancelled or withdrawn at any time in the sole and absolute discretion of NGE2006CL without notice or recourse. Any spending made on the day of the cancellation or withdrawal date of the Redemption or any time thereafter will not be entitled to redeem any rewards.

29. In the event of any dispute relating to anything set out in these terms and conditions, NGE2006CL reserves the sole right to make the final and binding decision. NGE2006CL also reserves the sole right to amend or change these terms and conditions at any time without notice or recourse.

Shoppers consent to the confidential communication and transfer of the Data to such service providers (properly licensed to provide such services under Macau law) who are engaged by the Galaxy Group at any time to assist with the administration, analysis and management of the Data. For the purpose of providing services to you, we may seek your separate consent to our disclosure to our employees, agents, contractors, subsidiaries, affiliates and third party providers, our collection and use of sensitive Data, or cross-border Data transfer activities involving other jurisdictions. Shoppers have the right at any time to update or revise their Data, or refuse or withdraw their consent for Data treatment provided herein by choosing to unsubscribe to any electronic newsletters or marketing communications, or by calling the customer services hotline at +853 8886 1027.
